Re: Report on the operating result of the reviewed consolidated financial statements for the third quarter ended September 30, 2021.

Dear Sirs,

TPI Polene Power Public Company Limited ("the Company") would like to report the operating result of the reviewed consolidated financial statements for the third quarter ended September 30, 2021 as follows:-

Total revenue from sales of power and goods and revenue from adders in Q3/2021 were Baht 2,878 million compared with Baht 3,011 million in Q3/2020, a decrease of 4.42%, as the units of power sale in Q3/2021 decreased. Total income in Q3/2021 was Baht 2,943 million compared with Baht 3,077 million in Q3/2020, a decrease of 4.35%.

In Q3/2021, the Company and its subsidiaries registered profit for the period of Baht 943 million (or basic earnings per share of Baht 0.112) compared with profit for the period of Baht 1,206 million (or basic earnings per share of Baht 0.144), a decrease of 0.21.83%.

Profit for the period of Baht 943 million in Q3/2021 was comprised of profit from operating activities (before finance costs and tax expense) of Baht 1,018 million, finance costs of Baht 47 million and tax expense of Baht 28 million, whereas the profit for the period in Q3/2020 of Baht 1,206 million was comprised of profit from operating activities (before finance costs and tax expense) of Baht 1,328 million, finance costs of Baht 87 million and tax expense of Baht 35 million.

For the first nine-month period of the year 2021, the Company and its subsidiaries registered profit for the period of Baht 3,192 million (or basic earnings per share of Baht 0.380) compared with profit for the period in 9M/2020 of Baht 3,345 million (or basic earnings per share of Baht 0.398), a decrease of 4.58%. Normal operating profit (before finance costs and tax expense) in 9M/2021 was Baht 3,484 million compared with the same of Baht 3,640 million in 9M/2020, a decrease of 4.27%.

As at September 30, 2021, the Company and its subsidiaries' total assets and total equity were Baht 46,857 million and Baht 29,853 million respectively. Details of consolidated financial statements for 9-month period ended September 30, 2021, can be summarized as follows:

Assets

The Company and its subsidiaries' total assets as at September 30, 2021 was Baht 46,857 million as compared with Baht 43,775 million as at December 31, 2020, an increase of Baht 3,082 million, or increased by 7.04%. Details of the major accounting change are as follows:
